GREATER MINNEAPOLIS CRISIS NURSERY SERVES AS A TRUSTED RESOURCE FOR PARENTS TO CALL IN THEIR TIME OF CRISIS, OFFERING A 24-HOUR CRISIS LINE, CRISIS COUNSELING, COMMUNITY REFERRALS, A HOME VISITING PROGRAM, AND A RESIDENTIAL NURSERY FOR PARENTS TO PLACE THEIR CHILDREN VOLUNTARILY WHILE THEY ADDRESS THEIR CRISIS.
